

There will be 125 voting locations on November 7<sup>th</sup>. Four of those locations will have two "groups" of precincts voting in them (ex: one group of precincts in the gym and one group of precincts in the cafeteria) and one location has three groups. The total number of voting groups throughout the county is 130. The changes to the previous plan are outlined below.

BCTC Cooper Campus; Montclair precinct	-----	Unable to use during the Fall since classes are still in session at UK and BCTC which greatly restricts space inside the building and parking outside. Montclair will be moved into Cassidy Elementary.
Woodland Christian Church; Woodland & Ashland Avenue precincts	-----	The church is experiencing construction much earlier than expected which affects the voting area. These precincts will temporarily be moved to two different schools. Woodland to Cassidy Elementary and Ashland Ave to Ashland Elementary.
Macedonia Christian Church	-----	The church requested to be removed from our list of voting locations and is being replaced by; David's Fork Baptist Church, 3245 N Cleveland Rd.
Crossroads Community Church; Chestnut Hill precinct	-----	One precinct is being moved out of Crossroads Community Church due to congestion within the voting area. The precinct is being moved to Athens-Chilesburg Elementary.
