During a Special Meeting held by the Owsley County Board of Elections on 02/29/2024, at 4:30 PM, at the Owsley County Clerk's Office, the Board voted to approve the same Election Plan for the upcoming 2024 Primary Election that was utilized for the 2023 Primary and General Elections and the 2022 General Election. A summarization of the approved plan is as follows: the location for the Drop-Box will be the Owsley County Clerk's Office, 20 Main St., Courthouse, 1st Floor, Booneville, KY 41314; the location for the 6-Day Excused In-Person Absentee Voting will also be the Owsley County Clerk's Office; the location and time for the Early/3-Day No-Excuse In-Person Absentee Voting will be the Owsley County Recreational Center, 99 County Barn Rd., Booneville, KY 41314, between the hours of 10:00 AM to 6:00 PM for all 3 days; and the location for Election Day will also be the Owsley County Recreational Center. On Election Day the basketball court area of the Recreational Center will be divided in half creating 2 Vote Centers at one location to assure no wait time for voters. The Recreational Center will be a Vote Center for all days of voting occuring there. The Board agreed that Elections previously conducted at the Recreational Center have been successful in all aspects.
